Report of committees

Radios:

Trucks and Equipment:

- The annual testing of the ground ladders and other assorted equipment (heat sensors etc.) is being done by 5 Star. - Twin Lights provided a quote of \$11K to fix the waterway on L30. We will also be asking 5 Star to quote so we can compare.
- SB has begun discussions on the replacement of the Hurst tools as they have reached (exceeded) the end of their lifecycle. Discussion ensued about the different brands (Holmatro) and what we would want to look for in a replacement. Consensus was that we would want to stay with Hurst to enable interoperability between all 3 departments. There will be further information provided on Hurst tool options in upcoming SB meetings.
- M34 is OOS until 10/24 for Westerbeke pump PM service.

Marine Division:

- M34 will be getting pulled 10/31 or 11/1 for PM depending on availability of qualified membership to help.
- Scott Sargent did a minor referb on the boat trailer of the wheels and brake components. A full referb needs to be scheduled.
